General terms and conditions for Package Travels

General terms and conditions for Package Travels that has been compiled by Virke and the Consumer Authority; <https://www.virke.no/pavirkningsarbeid/bransjer/reise/alminnelige-vilkar-pakkereiser-engelsk/> applies as a part of the Package Travel agreements. Certain special terms and conditions below contains a priority ahead of the General terms and conditions for Package Travels in the event of conflicted (Unless General terms and conditions for Package Travels is invariable whereupon the relevant part of the General terms and conditions will prevail).

Special terms and conditions – especially regulation and deviating provisions from the General terms and conditions

1. Booking and payment (cf. General terms and conditions point 1)

The order is binding when Arnfinn Johansen Wildlife Photography AS, here on referred to as («AJWP»), has I) received the deposit and II) signed booking form. The payment of the remaining sum has to be made no later than 60 days before departure. If the safari is booked later than 60 days before the departure, the whole sum has to be paid in full within 5 working days from time of booking.

2. Cancellation and refund (cf. General terms and conditions point 5.2)

A written cancellation is required and has to happen immediately if you are prevented from travelling. The customer has the right to cancel the trip with the following cancellation and administration fee:

- If the cancellation happens more than 60 days prior to the scheduled arrival date at Oltepesi, you will be refunded the amount you have paid excluding the deposit.
- If the cancellation happens 30 to 60 days prior to the scheduled arrival date at Oltepesi, you will be refunded half of the amount you have paid excluding the deposit.
- If the cancellation happens less than 30 days prior to the scheduled arrival date at Oltepesi or on commenced travel, no refund is made other than public expenditures that does not accrue.

If the trip is cancelled later than 60 days prior to departure, the outstanding fee is due immediately. If you for one reason or another receive a shorter safari because you are delayed i.e. the agreed meeting time for the safari or you decide to end the safari early, no refund will be supplied, regardless of the reason.

3. Travel insurance and cancellation insurance (cf. General terms and conditions point 4.1)

All participants are required to have a personal travel insurance that without any hidden limits covers all medical conditions (sickness/accidents/death) and evacuation/repatriation within the travel period. We would also recommend drawing up a cancellation insurance (these are often included in the travel insurance). See General terms and conditions point 4.1 and any other information given in regards of your Package Travel.

4. Health (cf. General terms and conditions point 4.3)

You need to be in general good health to travel. It is important that participants notify AJWP prior to departure if they have any medical issues or any dietary requirements. Participants confirms that they do not suffer from any physical or mental disabilities that can potentially put themselves or others in any danger/inconveniences on the trip through signing this form. As part of the General terms and conditions point 4.3, you are required to inform us of any health-related issues.

5. Change in price

As mentioned above, see General terms and conditions point 3.1 and any other individual agreements concerning change in price. Package Travel prices will increase or decrease in relation to adjustments in local taxes and fees, and/or transportation fees, and/or relevant currencies.



6. Reservations and limitations of liability – especially on safari trips that you accept

Due to the nature of this trip it is not always possible to predict the exact way it will play out. This type of risk is included in safari trips, and the participant has to accept that before deciding to book the trip. To follow up on this we can give examples (although not exhaustive) on risks that will *not* be considered as inconclusive or provide a basis for a refund by the Package Travel law and General terms and conditions chapter 8, point 8.2 and 8.5:

Concerning weather, mechanical issues, political conditions and so on:

AJWP is not responsible for (not exhaustive listing): weather, water levels in the rivers, transport accessibility, mechanical issues and repairs, change of safari car, illness among the staff or our affiliates, including swapping of driver/guide, change in rules set by the national park authorities, strikes, war or riots, death, political conditions, natural disasters, change in flight time schedules by the airlines or line stretches, missed flights and other factors, or other circumstances that AJWP or our agents or affiliates cannot control. Circumstances like these can force change, but these will then not result in an inconclusive trip according to this Package Travel agreement hence it will not give the right to a discount, compensation and so on. As a person placing the order, you confirm that all the participants has been informed and agreed to these terms.

Limitation of liability:

AJWP, their owners, affiliates, employees and agents cooperates with suppliers of transportation and other travel services, are not liable for extra costs, accidents, material damages, loss or damages to personal belongings that are directly or indirectly a result of all of these services and experiences delivered, this includes transportation by air planes, cars or other vehicles, game drives, safari, off road driving, close proximity to wild animals or wildstock, accommodations, dining, or experiences affected by weather, natural disasters, floods, earthquakes, acts of God, disease, virus/pandemic, delays, car issues, quarantines, strike, theft, robbery, terrorism, and/or other unforeseen circumstances we cannot control. Changes in the travel itinerary can be made to suit the circumstances. See limitation of liability in the General terms and conditions point 8.3.

Limitation of liability in the event of participant getting sick or subject to accidents:

If a participant get sick or is subject to accidents that requires medical attention, hospitalization, evacuation and/or repatriation of participants, the participant will then be responsible for the payment of these services. AJWP requires that all the participants has drawn up their own insurances that covers all of these costs. If a participant does not obtain an insurance policy covering these services, the participant is still responsible to pay the cost of the services and AJWP renounces all responsibility.

7. Cancellation of the trip (cf. General terms and conditions point 6)

If the trip is cancelled, you will receive a refund of the paid Package Travel price, but AJWP is not responsible to provide refunds concerning the participants other expense, like airplane tickets, visa or passport expenses, equipments accrued before the trip or other expenses related to the trip.

8. General information concerning travel guarantees (cf. General terms and conditions point 4.5)

The travel guarantee foundation applies to the purchase of Package Travels, this ensures customers will not suffer loss if the organizer experiences bankruptcy, debt settlement or insolvency. 9. Law and jurisdiction

This agreement is interpreted and subordinated in accordance with Norwegian law. For further information, see General terms and conditions point 9.
